Civil Society Report on Human Rights in Kosovo in 2022

We are pleased to announce that the Human Rights Network (HRN) has officially published the fourth joint civil society Report on Human Rights in Kosovo in 2022.

In total 37 NGOs participated in the drafting of the report.

In the report, there are 163 recommendations directed to institutions for the improvement of the Human Rights Situation in Kosovo.

We look forward to continuing our relationship with journalists in our fight for freedom of speech and improvement of the human rights situation.








3-Day Training On Capacity Building For Public Speaking & Lecturing On Human Rights

Ten law students from different universities, public and private, in Kosovo, had the opportunity to build their capacities in public speaking and lecturing on human rights, rule of law, and the justice system for elementary school students.

During the training, the participants were informed about and learned how to put into practice the Human Rights Education Program for Young People. Furthermore, they gained knowledge and skills on public speaking and lecturing to elementary school students about human rights and the Kosovo justice system.





Human Rights Lectures in Elementary Schools

After the training on public speaking and lecturing on human rights, the 10 law students conducted a series of 15 lectures in targeted municipalities to provide young people with essential knowledge about their rights and access to justice.

Young primary school students had the opportunity to engage with court representatives and gain practical insights into court proceedings. By fostering experiential learning and meaningful discussions, these lectures and court visits empowered young individuals to actively participate in civic life and develop a heightened awareness of justice.






Training with professors on Civic Education

15 primary school teachers from the municipalities of Fushe Kosova, Shtime, Vitia, Prishtina, and Prizren were part of a 5-day training on human rights, the justice system, and access to justice. These dedicated educators had the opportunity to dive into the practical aspects of teaching legal sections to their students and learn how to research and bring real-life cases to the classroom for discussions.

The training was designed based on the "Human Rights Education Program for Young People" manual, which was created by YIHR KS.





Study visits with Civic Education teachers

With the 15 teachers from different regions of Kosovo, we visited the Constitutional Court of the Republic of Kosovo and the Ombudsman Institution.

During these visits, the teachers had the opportunity to refresh the knowledge acquired during their preliminary training, hearing first-hand about the work of these institutions as well as discussing topics regarding the rule of law and the function of legal mechanisms.






Living Library

The event brought together kids and grown-ups from all walks of life and a variety of ethnic backgrounds under the tunes of pleasant and exciting artists, reciting poetry and playing music.

Mock Trials - Gjilan & Mitrovica

Sixty law students from the region of Gjilan and Mitrovica participated in the Mock Trial, a 3-day simulation training. They learned more about the justice system and the role of judge, prosecutor and lawyer from one professional trainer and six facilitators in each of the sessions.

On the last day, all students had the opportunity to organize a simulated court session at the Basic Court of Gjilan and Basic Court of Mitrovica.

National Mock Trial (2 editions)

Two National Mock Trials were organized during the January-June 2023 period. This activity is a three-day simulation training which gathers 30 students from all around Kosovo. One trainer and 6 facilitators held workshops, lectures and discussions regarding the justice system in Kosovo. This activity brings law students closer to the law professions they want to practice in the future through non-formal education and deeper understanding of human rights.

On the last day, all students organized and participated in a simulated court session at the Basic Court in Prishtina.




Storytelling Workshop - Day Trip




The Future Begins By Knowing The Past

Peace Academy - Phase 1

The Peace Academy, the first of its kind in Kosovo, took its participants in a powerful educational journey to learn more deeply and theoretically about peacebuilding, reconciliation, conflict transformation and resilience.

The Academy, established by YIHR KS in partnership with Plan for Peace (UK) brought renowned scholars from prestigious world-leading universities alongside peacebuilding leading experts from Kosovo to nurture a new generation of peacemakers in Kosovo. Some of the universities include Dublin City University (Ireland), Columbia University (US), Graz University (Austria), Oxford Brookes University (UK), Nottingham University (UK), Ruhr University of Bochum (Germany), and Singidunum University (Serbia).




We March, We Don't Celebrate - International Women's Day

Who is Mr. Clown? He is the representative and embodiment of our decision makers and politicians in power who consistently fail to uphold the Constitution and protect human rights.

The disrespect towards our Constitution by those whose only job is to abide by it needs to stop now. Human rights violations, from identity-based discrimination, gender-based violence, femicide, queerphobia, and hate speech in public discourse, leave us all in a bad situation in Kosovo regarding human rights.

This performance served as a reminder of the reasons those in power hold these positions, and the responsibilities that come with said power. We demand that compliance with the Constitution and the protection of all human rights and freedoms be of highest priority and taken on with full seriousness by all institutions and decision-makers.

Placing of the Plaque -National Day of Missing Persons

YIHR KS organized a street action at the Ibrahim Rugova square in Pristina to mark the National Day of Missing Persons. The action aimed to bring attention to the agony of the families of the missing persons, who have been waiting for years to find out what happened to their loved ones.


As a symbolic gesture, YIHR KS placed a plaque at the Memorial of Persons of Enforced Disappearances during the last war in Kosovo. The plaque is intended to mark the memorial and what it represents. Since the memorial was put up, there has been no official marking to explain its purpose. This has resulted in years of institutional negligence towards the families of the missing persons.

The plaque that YIHR KS placed is in five languages, Albanian, Serbian, Roma, Turkish and English, and serves as a reminder of the more than 1600 people who are still missing since the last war in Kosovo. Through this action, we called upon our institutions to prioritize the enlightenment of the fate of the missing persons.

The plaque serves as a symbol of hope and solidarity for the families of the missing persons, and a reminder to the institutions that they cannot ignore their responsibility to seek the truth and provide closure to the families who have been waiting for more than 20 years.



Reaction to the derogatory language used by Deputy Valentina Bunjaku-Rexhepi during the session of the Assembly of Kosovo

The Human Rights Network (HRN) strongly condemns the derogatory language used yesterday, on June 22, 2023, during the session of the Assembly of Kosovo by Deputy Valentina Bunjaku-Rexhepi, who is also a member of the Committee on Rights and Interests of Communities and Returns.

In yesterday's session, during a discussion on public finances, the LDK Deputy Bunjaku-Rexhepi used the word "magjup" with the intention of demeaning Deputy Adnan Rrustemi. The pejorative language used in the Assembly of Kosovo yesterday displays an offensive, insulting, and derogatory behavior of the deputy towards non-majority communities in Kosovo. This kind of approach is not only unacceptable but also harmful when it becomes part of public discourse by people's representatives.

HRN is concerned about the lack of reaction to such language from the Speaker of the Assembly of Kosovo, Mr. Konjufca, and other present deputies, which in a way legitimizes such jargon in an important public institution.

Furthermore, such practices of using discriminatory language and spreading hatred from the podium of the Assembly of Kosovo have become frequent, and such a practice is dangerous and has a long-term effect on the dignity and integrity of marginalized communities in Kosovo, and it may lead to further marginalization of certain groups or individuals.

HRN calls on the Speaker of the Parliament, Glauk Konjufca, to condemn the discriminatory language used in the Assembly of Kosovo during the next session, to take administrative measures against the respective deputy in accordance with the rules of procedure of the Assembly, and at the same time, HRN calls on all deputies to raise awareness and stop discrimination, hate speech, and racism against non-majority communities and citizens of Kosovo.



The Case of Klan Kosova

Statement: The case of Klan Kosova

As member organizations of the Human Rights Network (HRN), we are extremely concerned by the recent decision of the Ministry of Industry, Entrepreneurship and Trade (MINT), respectively the Business Registration Agency of Kosovo (BRAK), to suspend the business certificate of the Trading Company "Klan Kosova" LLC, part of which it is also the Klan Kosova public television.

The Ministry of Industry, Entrepreneurship and Trade (MINT) announced on June 14, 2023 that it has submitted a criminal complaint to the Kosovo Police, Serious Crimes Department, against Klan Kosova and other officials from the Business Registration Agency on suspicions of misuse of official duty, as well as misuse of economic authorizations.

The Human Rights Network (HRN) considers this decision as a direct violation of freedom of expression and media. The Republic of Kosovo is a democratic state with a Constitution that guarantees human rights and freedoms, including that of freedom of expression and free press. The suspension of Klan Kosova's license without due process by court of law and based on legally unsubstantiated suspicions creates a dangerous anti-democratic precedent and suppresses basic rights such as freedom of expression.

The decision by MINT resembles an attempt to control the media and limit free speech. Therefore, we are very concerned about the message it conveys not only to Klan Kosova but to every other media in Kosovo. Free and independent media must conduct their work ethically and professionally. No government decision has competency or legal authority to interfere in this essential process for the functioning of a democratic society.

Human Rights Network strongly supports the freedom of media and expression, and stands in solidarity with all media institutions, and the journalists who perform an incomparable job on a daily basis exercising these freedoms.

A democratic society requires full functioning of law and order, and we appreciate every effort towards this. But the suspension of the work of a media outlet by the Ministry of Industry, Entrepreneurship and Trade is anti-Constitutional and undermines human rights and democratic principles in Kosovo. We cannot, in any way, allow the creation of such intimidating and threatening precedents in regards to freedom of expression and freedom of the media. We call on Prime Minister Kurti to immediately cancel the decision of MINT and take immediate actions against Minister Rozeta Hajdari for these unacceptable actions towards the very fundamental democratic values.

Civil society demands immediate de-escalation of the situation in the north of Kosovo

Civil society is following with great concern the situation created in the north of the Republic of Kosovo after the decision of the four mayors elected in the municipalities in the north of the country to start work in their offices. Such an action has provoked reaction and violent protests in the four northern municipalities, where journalists, police and KFOR soldiers were the targets of the attacks.

As non-governmental organizations, we ask that stability, peace and security in the north of Kosovo be the main guide for all parties involved. All disputes must be resolved through dialogue, while violence and unilateral actions must cease immediately. We believe that the promotion and protection of peace and human rights for all citizens, and especially for the marginalized groups in Kosovo, have no alternative and must always be the priority of every decision-making process. Violence against citizens, public authorities, members of the international security forces as well as the media is a serious violation of human rights, order and security in Kosovo, and moreover hinders the process of peace and reconciliation.

From our fieldwork with citizens of the Serbian community and all other communities living in Kosovo, we are noticing the negative impact of the irresponsible actions of state actors in both Pristina and Belgrade, directly affecting the wider inter-ethnic relations in Kosovo. The consequences of the actions undertaken in the north of Kosovo affect all citizens of Kosovo, therefore the situation must be handled in a peaceful, careful and sensitive manner.

The well-being of all citizens should be the guide and starting point of every decision-making by public institutions. Civil society condemns any provocation, threat or intimidation by any party that only worsens the situation and does not bring concrete results in greater representation and respect for the rights of the communities living in Kosovo.

Civil society calls on the government of Kosovo and Serbian representatives in Kosovo to stop unilateral actions and make appropriate compromises to overcome the situation created in the north of Kosovo in full coordination with the international community and other parties focusing on dialogue between Kosovo and Serbia.

On the other hand, we call on the authorities in Serbia to stop their war-inciting rhetoric in Kosovo and to be constructive in reaching a peaceful solution through dialogue mediated by the European Union.

Peace and security are always the solution and the institutions in Kosovo should work immediately towards reducing the tension in the north and reaching a solution which would help in the greater integration of the Serbian community in Kosovo.
